Aims

- 1) To enjoy the sport of sea angling in a friendly atmosphere and to promote the sport in a way that makes such enjoyment accessible to others.
- 2) To encourage people to fish in a manner that takes conservation firmly into account and discourages both cruelty in the treatment of fish and disregard for the marine environment.
- 3) To organise competitions, challenges and events that promote the sport and help to develop both the social and angling sides of the club.
- 4) To operate in a democratic manner that takes everybody's views into account.
- 5) To organise fund raising events that support club activities and purchase additional resources to benefit all members.
- 6) In a spirit of friendly competition, to maintain records of fish captures in junior, senior and ladies sections, making them available to members upon request.
- 7) To ensure that members may enjoy their time with the club without any fear of harassment, bullying or intimidation. Further to ensure that activities are carried out in a safe manner and location that minimises the likelihood of harm to any club member or member of the public that may be present at a club event.

Background

Baywater Anglers is an established club with, we like to believe, a refreshingly different way of doing things. **Every** member, for example, has a say in what we do, be they eight or eighty, and all dealings on behalf of the club are held open for public inspection, including accounts, letters etc. There are no closed committee meetings and **everybody's** feelings, views and ideas are taken into account. We try to do our best for all members, with the following offering perhaps a flavour of what the club is about:

Specimen Award Scheme

We believe that the capture of an exceptional fish is something to celebrate, so we run a specimen award scheme, with quality medals awarded for **all** specimen fish that are caught.

Training Programme

Many of our anglers are fairly new to the sport but we have an Angling Trust qualified coach - Martyn Green - who is both a tri-discipline coach and Coach Educator. At each of our events, you can approach him for help with any aspect of fishing and he will do his best to put you on the right lines. In addition, Martyn maintains, upon request, Angling Trust CAST (Core Angling Skills and Techniques) certificates that will, upon completion, enable anglers to target the Level 1 Angling Trust qualification on their way to becoming a professional coach.

We are also lucky enough to have some accomplished anglers who do their best to help with problems. There is a nice, supportive atmosphere with friendly people ready and willing to help people progress in the sport.

Prizes

Prizes are awarded every year for the best fish weighed into the club. (Only two prizes per angler, one for each of his or her best two fish.) We do not give trophies but last year, for example, we awarded over £1000 worth of tackle prizes to our lucky winners.

Insurance

As members of the Angling Trust, we automatically receive public liability cover to a maximum of £10 000 000, more than enough, we hope, to cover any accidents that may befall the public!

Discount

Discount is currently offered at Brixham Bait & Tackle and Euro Angling (Torquay) upon production of a valid membership card. **Please note**, however, that discount may be subject to a minimum purchase or exceptions. Please enquire in each store for details.

Blanket permission for club members to fish the River Dart from the Railway Bridge, Totnes, to the sea.

This stretch of water is controlled by the Environment Agency and requires special permission to fish. We have been granted such permission, using rod and line only, subject to certain conditions. These are that we can only use float or leger tackle and sea baits (except for sandeels, which are banned by DEFRA) and that we must return all fish caught to the water (with the exception of sizeable mullet and flounders). Technically, we can retain any sizeable bass but we feel that this goes against the spirit of a bass nursery area. We would therefore urge all members to please return all bass that they catch. Fly fishing and spinning are not allowed under any circumstances.

Loan Equipment

Thanks to Sports 4 All and Active Devon awards, we have been able to invest in several pieces of equipment for our members to borrow. These include good quality fishing outfits (available for club events upon request) for use from either shore or boat and lifejackets that any club member may borrow on demand. There are also two family tents that are available for members to borrow. We have also, thanks to Devon Community Foundation, been able to purchase some excellent fly tying kits, rods and reels for any club member to use free of charge.

Events

The club organises open and club only competitions, organised boat trips, tackling a variety of species, and a number of social events, which have included casting events, camping weekends at Woodlands and holidays at other campsites, barbecues etc. We have been lucky enough to attract major sponsorship for some of our open competitions while half of the club profits are routinely spent on tackle prizes to be awarded to club members through our prize scheme and at club only events.

Rules

1) Policies of the club will be decided through open meetings which everyone is encouraged to attend. Some members may, with our gratitude and subject to the approval of those members present, wish to undertake special duties, for example membership, social events, correspondence and finances, reporting back to the club and holding all dealings open to public inspection.

2) All members shall pay a subscription to the club, which reserves the right to defer or refuse any application which members feel warrants careful or further consideration. Subscriptions shall be due on 1st October of each year, with the previous year ending on 30th September. **Please note** that fish for weighing in may not be accepted unless subs have been paid in advance or, under special circumstances and subject to approval by the membership, not later than on the day of capture itself.

Because of safety issues, Baywater Anglers will not accept **independent** membership applications from children of primary school age. They are quite welcome to join as part of a family membership but not on their own. The reason for this is to ensure their safety at waterside events, to which they must be accompanied by a responsible adult. With parental involvement, it is also our hope that they will subsequently have more opportunities to practice and develop their skills. At the time of writing subscriptions stand at:

Please note that fish for weighing in may not be accepted unless subs have been paid in advance or, under special circumstances and subject to approval by the membership, not later than on the day of capture itself.

3) Juniors are defined as those members being under 16 years of age. After their sixteenth birthday, any fish that they catch are treated as senior entries into all club awards or competitions.

4) The club **does not** purchase trophies for its members but operates instead an award and specimen medal scheme for exceptional fish. Half of all the profits from each year are used towards the purchase of prizes that celebrate the best fish caught by club members.

5) To qualify for prizes or awards, fish entered by Baywater Anglers must be caught in South Devon. Where the fish are taken on boat, the deciding factor will be the port from which the boat leaves, with the exception of boats travelling to the channel islands, which will not be admissible. All fish caught over a wreck or five miles out from the shore will count as wreck caught fish.

6) Fish entered for club awards must be caught using fair angling means and must not be foul-hooked. Fair angling means is defined as follows:

- Float-fishing, spinning, trolling, legering, pole-fishing and fly-fishing. (Neither feathering nor sink or draw methods count as fair angling methods. All fish so caught do **not** count towards records or awards.)
- No more than two rods may be used, with a maximum of three hooks shared between the two rods (**not** three on each rod). A treble hook counts as three hooks.
- Each entrant must cast and retrieve the tackle upon which a fish is hooked for themselves with the exception of anglers under the age of ten. They may receive adult assistance with casting, **not** reeling in fish, provided that the distance cast does not exceed the distance attained by other children casting for themselves. Any other exceptions to this can only be allowed after a meeting at which all members present have the right to vote upon the proposal.

All fish entered for prizes will be compared against Baywater Anglers specimen weights and will only be accepted if the angler's subscription is current and valid.

7) The club reserves the right to expel members whose conduct brings the club into disrepute, or whose actions threaten to spoil the friendly atmosphere that we have worked so hard to build.

8) Weighing-in

All fish entered for club prizes or awards must be weighed on either the club scales or certified scales held by other angling clubs or shops, e.g. a tackle shop or fishmongers. The weight must be witnessed by either a nominated person from the club, a senior representative of the shop or by an official of another angling club. You **must** notify Martyn Green as soon as possible with details please. At the time of writing, fish below three pounds in weight may be weighed in at Brixham Bait and Tackle. Larger fish, as well as smaller ones, may be weighed in at either Euro Angling or with Martyn Green, 31 Collapark, Totnes (please telephone Totnes 863279 to arrange a convenient time).

9) Deferred Entry

Anglers who wish to join the club from October onwards shall be given the choice of a deferred entry. This means that they still pay a full subscription, but must decide whether they wish to compete for the awards being made in the year of joining, in which case they must then renew their subscription in January, or would prefer that any fish that they weigh in should be held over towards the awards in the new club year starting on 1st January. Whatever their decision they may, however, still compete for day prizes in competitions.

Deferred entry subscriptions are charged at the appropriate rate for the age the member will be on 1st January, the start of the new club year.

10) Matters Arising

Although it is our intention to keep the number of rules in the club to a minimum, we anticipate that there may be occasions when a matter arises that is not covered by the above. On such occasions the issue will be referred to the next club event, when the members present will be asked to vote on any action that needs to be taken with the decision confirmed by a simple majority.

Multiple Species Awards

In addition to the specimen medals that can be won at Baywater, we introduced two embroidered badges that anglers may wish to collect. These are awarded for captors of specimen fish who have, over time, caught either five or ten different species.

Since it is pretty unlikely that a single angler is going to get all the necessary specimens in a single year, we have set up a record keeping system detailing the size and species of all specimen fish caught by Baywater members. Even if you take a break in a particular year, past fish are still kept on record so that, should you choose to rejoin, any specimens caught previously could still count towards an award.



We feel that the badges offer anglers something different and are proud of the way that they have turned out. (The cloth badges are very slightly different from our original drawings, which we have put on this page to give you an idea as to what they look like. On the actual badges, 'Baywater Anglers' has been increased in size and now curves up from the left of the number to just over the bass.)

Since we have also introduced specimen sizes for most coarse species, including rainbow and brown trout, we feel that Baywater members have a sporting chance at winning one, or both, of these handsome badges. Hopefully they will make a stylish addition to a smock or a coat!

... vote on club proposals.	... vote if you do not understand what the adults are talking about.
... be a member of the club but only if you pay your subs first.	... weigh in any fish caught before you paid your subs.
... only, if you are eleven or under, be a member if your whole family joins.	... go fishing on your own. Always have an adult with you.
... only weigh in fish for junior awards if you are under sixteen.	... weigh in fish for junior awards after your sixteenth birthday.
... only qualify for two annual prizes.	... weigh in fish caught outside of South Devon waters.
... float fish, spin, troll, leger, pole fish and fly fish.	... feather or use sink and draw methods.
... use up to three hooks between two rods.	... use more than one treble hook, which counts as three hooks.
... if you are under nine, have an adult help you with casting.	... let that adult cast you further out than other children casting for themselves.
... have help with landing a fish.	... have help with striking, hooking and playing a fish.
... if you please, do your best to act in a sensible and polite manner.	... behave really badly. The club will take action if you do.
... only weigh in fish with people using club recognised scales.	... weigh in fish anywhere else.
... have deferred entry if you pay your subs after April.	... do this without talking to Martyn Green first of all.

Brixham Bait & Tackle

In a very convenient place for Brixham boat anglers, situated right opposite the inner harbour, Brixham Bait & Tackle offers a wide range of gear for sea and coarse anglers with a small selection of tackle for fly. Service is friendly and helpful with the staff willing to put themselves out to accommodate their many customers.

This is particularly useful for disabled anglers since wheelchair access, though possible, is a little bit cramped. Parking, however, is a plus for wheelchair users since they can usually park right outside the store and then make use of the ramp to enter the premises.

As you can imagine, situated right next to the harbour, bait is a priority for the shop, particularly as it serves many customers who either own their own boats or who are going out on charter trips with the local fleet. Graham likes to open early, around 8.00 a.m., for these and other anglers, which can be very helpful for last minute decisions about bait.

Most of the major brands are stocked and there are plenty of special offers to tempt you as you browse through the goods on offer, including a wide range of fixed spool reels. All the bits and pieces necessary for making terminal rigs are stocked and there is also a selection of pre-tied rigs.



There are plenty of rods to choose from and, as you can imagine from a store so close to the harbour, a good range of multipliers to cope with fishing from both shore and boat.



A good range of fresh and frozen bait is available in store but be sure to check availability of baits such as peeler crabs or live prawns by telephoning 01803 853390 beforehand. This is especially important when there are local competitions or festivals being held.



For the carp enthusiast Graham, who is himself a keen coarse angler, holds a good range of carping accessories, many of which are directly transferable into light tackle rigs for the sea.

The shop also boasts a good range of spinners and lures, including all the jellies necessary for a good day's pollacking. There are also plugs and flies on hand for bass and trout.

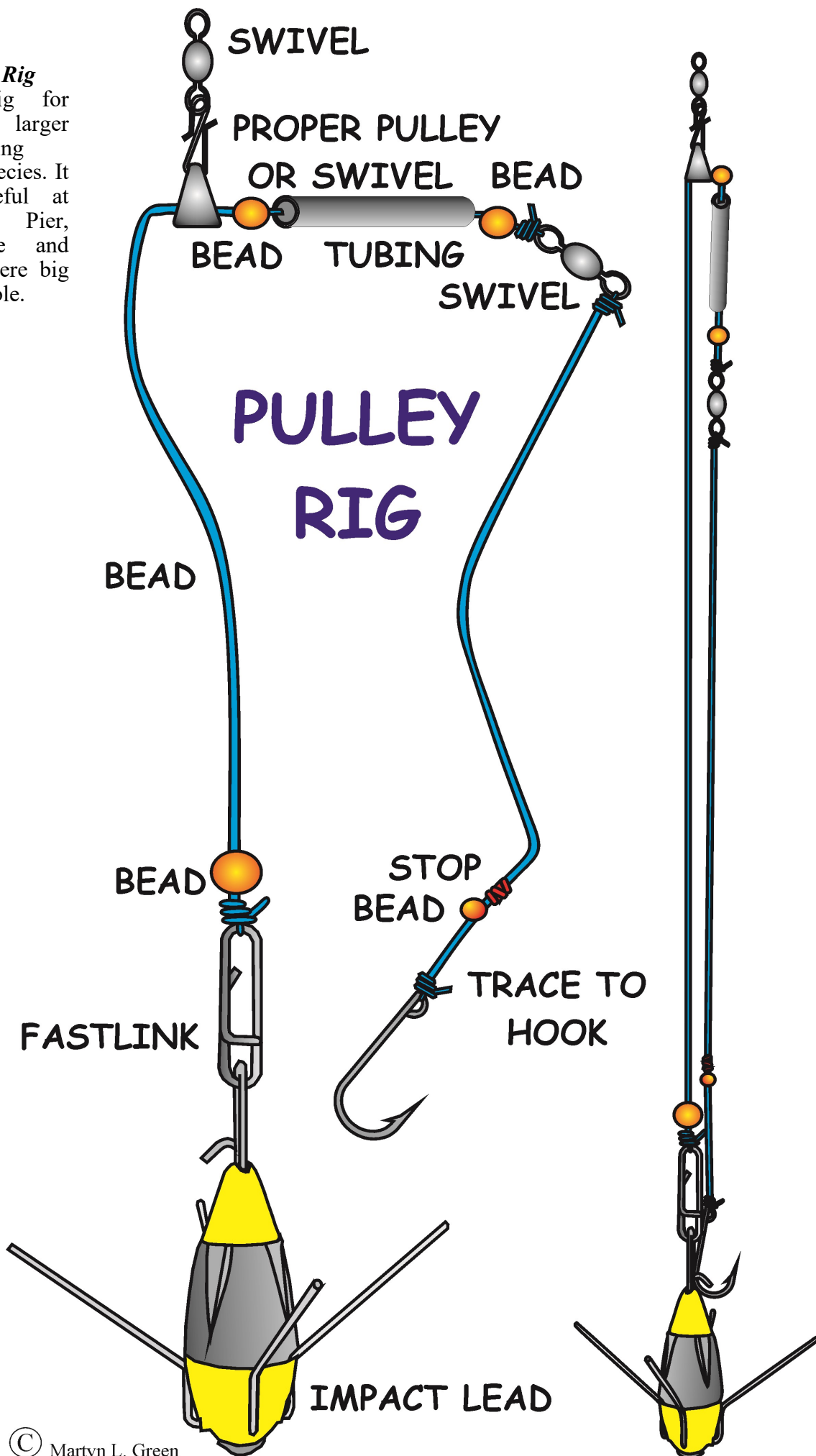

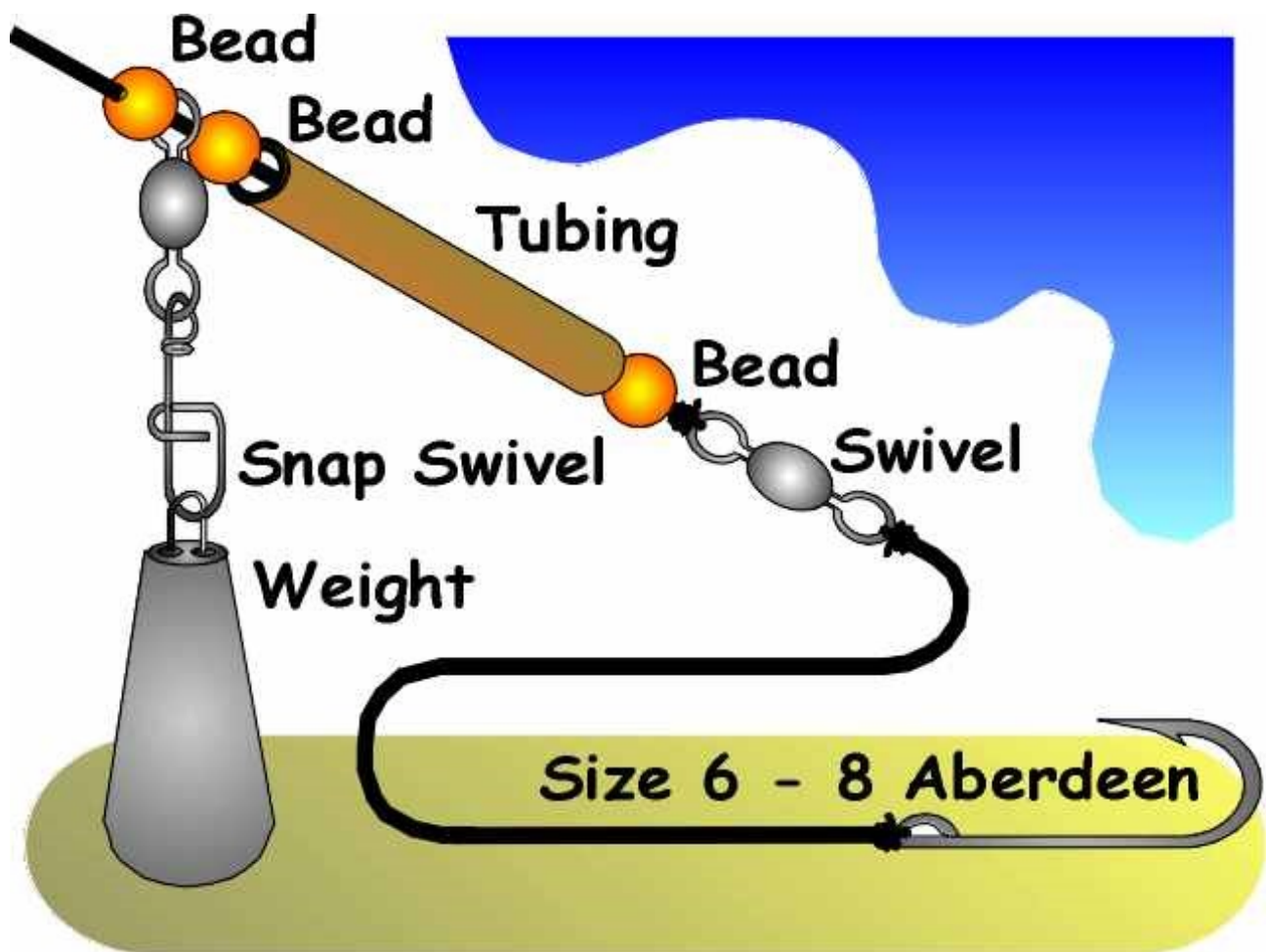

Basic Rigs

1. The Pulley Rig

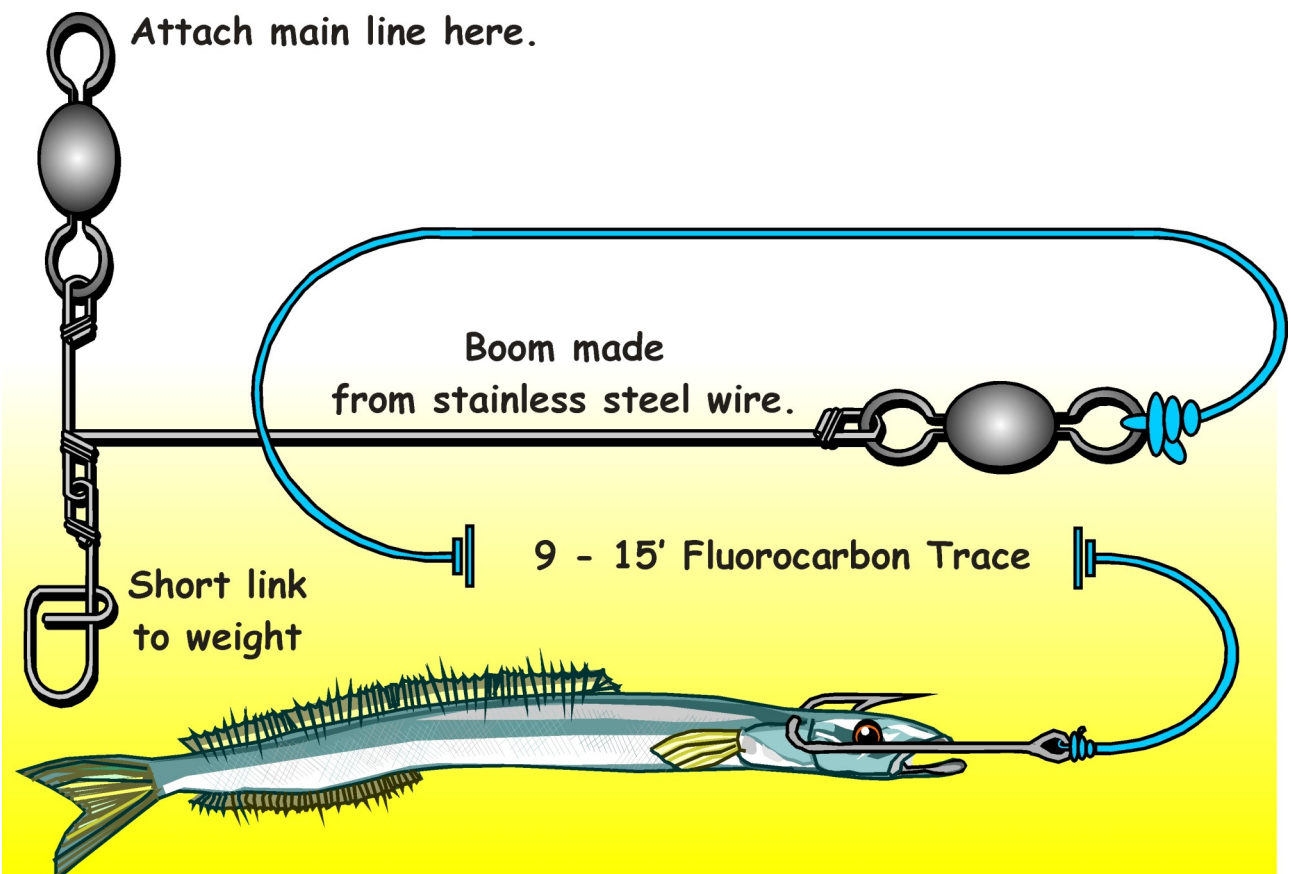
A good rig for dogfish and larger bottom-dwelling (demersal) species. It is very useful at Babbacombe Pier, Hopes Nose and anywhere where big fish are possible.





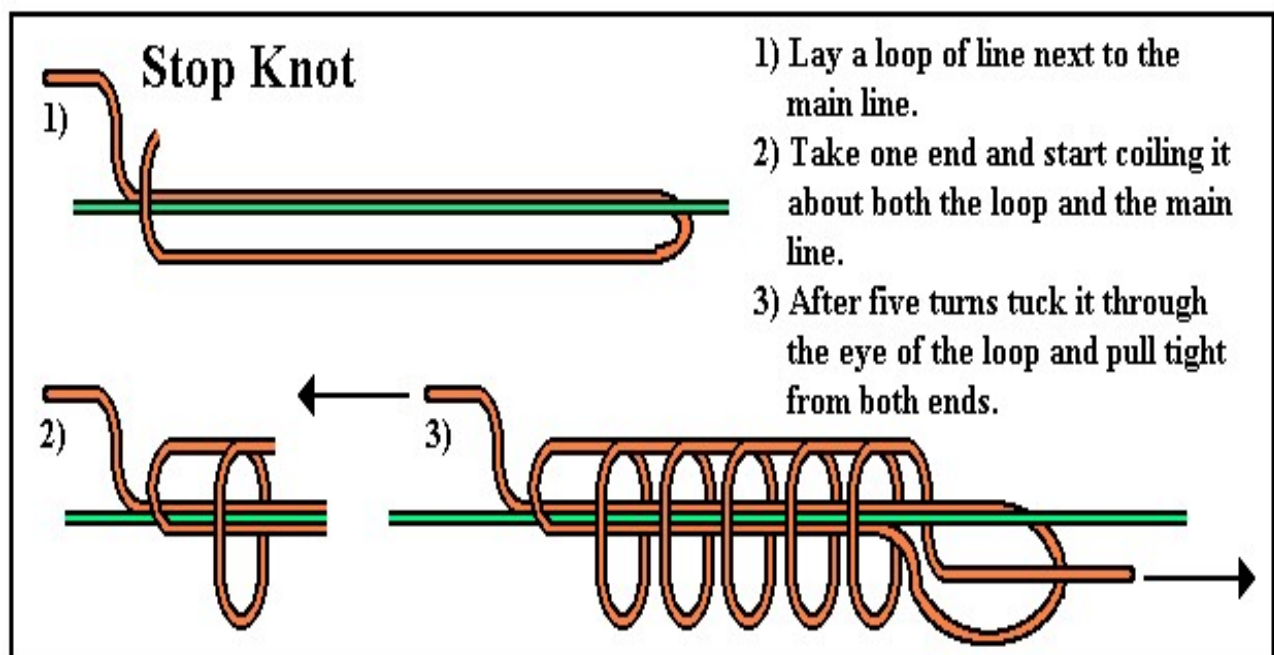
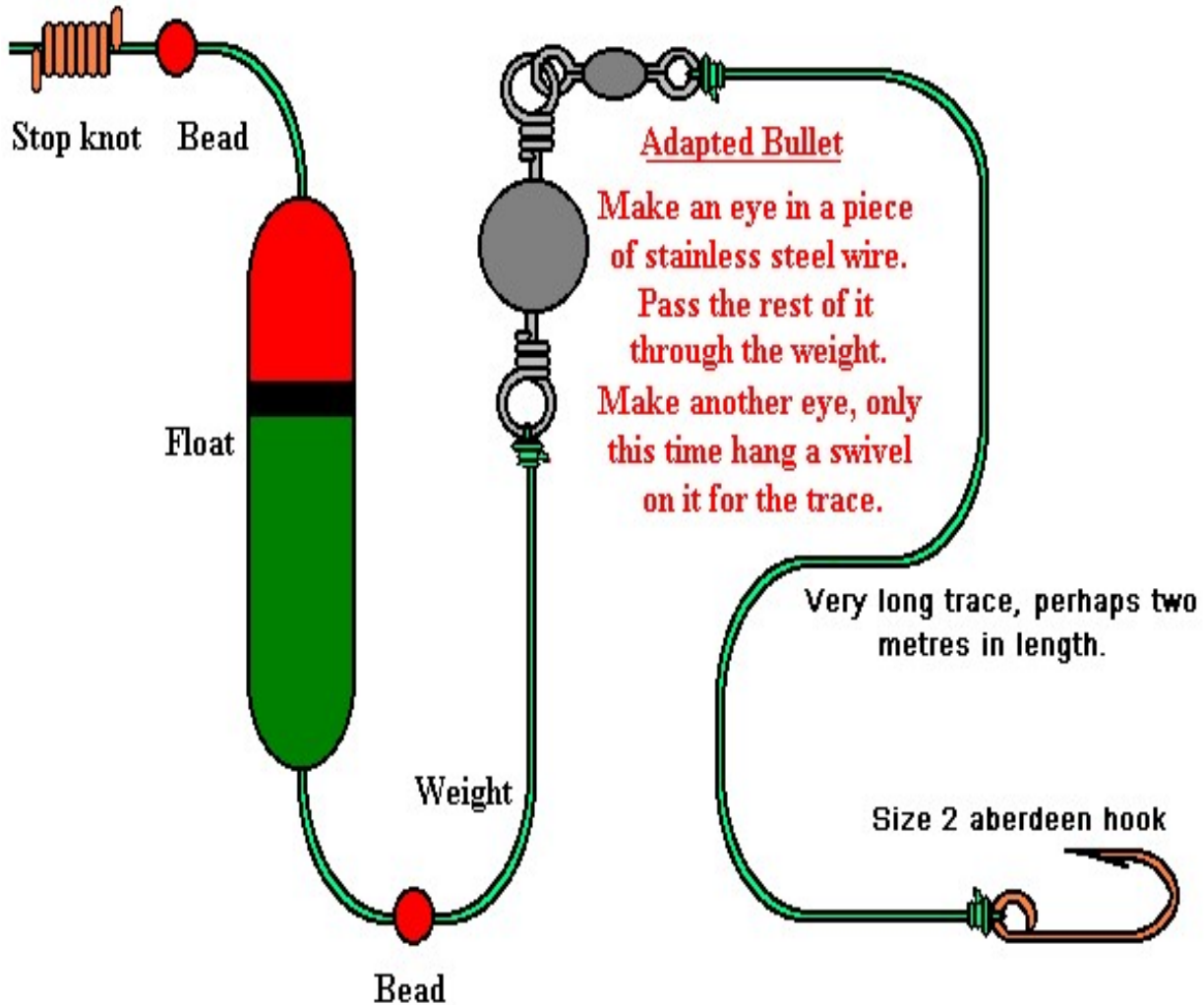
2. Flowing or Running Leger

The standard rig for boat but shorten the trace for shore fishing. Hook size will depend upon target species. For many boat situations, wire booms offer significant advantages.



3. Float Tackle

Probably the most widely used summer tackle in the bay, float tackle will account for scad, mackerel, pollack, bass, garfish and a variety of other, occasional species. It is simple to put together but can break quite easily after a bit of use. This is because of the metal edges in the drilled bullet, which rub and fray the line, making it weaker. A simple adaptation, which prevents this problem, is shown below.



The Grinner Knot

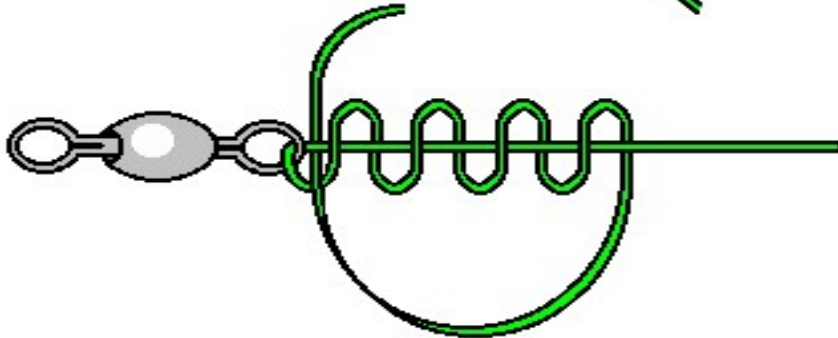
This is probably one of the best knots to use for sea fishing, or any type of fishing for that matter, with a high knot strength and a tucked end that does not jab a taking fish.



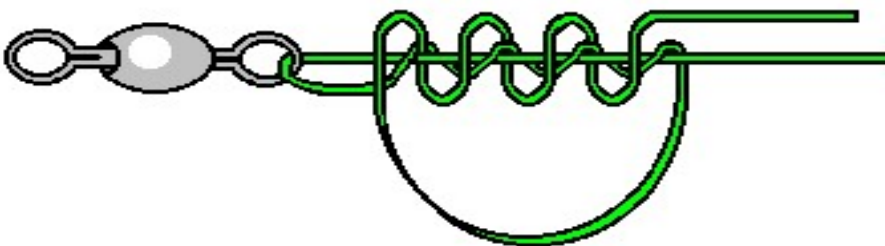
Pass through eye of
swivel, hook etc.



Make four turns about the line.



Pass back through the first twist, working top to bottom. Pull up into a loop.



Still working top to bottom, make four turns about the twisted strands.

Because we work with young people, both at club events and within primary schools, we are required to have a safeguarding policy. Such a policy is also essential for consideration in regard to grants for equipment.

Baywater Anglers - Safeguarding Policy

Background Information

Baywater Anglers is a sea angling club with the following aims:

- 1) To enjoy the sport of sea angling in a friendly atmosphere and to promote the sport in a way that makes such enjoyment accessible to others.
- 2) To encourage people to fish in a manner that takes conservation firmly into account and discourages both cruelty in the treatment of fish and disregard for the marine environment.
- 3) To organise competitions, challenges and events that promote the sport and help to develop both the social and angling sides of the club.
- 4) To operate in a democratic manner that takes everybody's views into account.
- 5) To organise fund raising events that support club activities and purchase additional resources to benefit all members.
- 6) In a spirit of friendly competition, to maintain records of fish captures in junior, senior and ladies sections, making them available to members upon request.
- 7) To ensure that members may enjoy their time with the club without any fear of harassment, bullying or intimidation. Further to ensure that activities are carried out in a safe manner and location that minimises the likelihood of harm to any club member or member of the public that may be present at a club event.

These aims reflect our values, specifically...

...that the sea is a unique and wonderful resource to which all members of a seaside community should have access. In this respect, Baywater Anglers regards sea fishing as a traditional sport that not only encourages a love of nature but which also may become a fundamental part of peoples' lives, helping them both to enjoy their recreational time and manage the stress that is a part of adult life. We believe that anyone, regardless of age, colour or creed, should be able to enjoy the sport of sea fishing and that this enjoyment is made greater when shared in the company of others. It is also our belief that disabled people may benefit from time spent sea fishing and we will, accordingly, schedule a significant number of events that may be accessed by wheelchair users and others.

At Baywater Anglers, we believe in the sharing of knowledge and the promotion of interest in both the sport and the marine environment itself. We believe that this should be done in a friendly atmosphere in which members feel safe and free from intimidation or bullying. We also believe that respect for the environment and serious regard to conservation are both issues that should be given a high priority in the running of the club.

We believe that sea fishing is a sport that has contributed much to the local economy, to people's lives and to the history of our community. We wish to preserve this and to pass our knowledge and our love of sea angling on to the next generation, thereby helping to ensure the future of the sport. In this respect we will actively seek to promote angling activities that will help to raise the sport's profile and encourage not only interest but also public participation.

At Baywater Anglers, we believe in a club that is run in a democratic manner, where everybody, regardless of age or sex, has the right to vote on issues of importance to the club. All such issues will therefore be presented at open meetings or events, where the members present will vote on the necessary decisions. In the event of poor attendance – less than ten members – the matters being considered will be postponed for debate at a future event where there are sufficient members attending. We understand that some jobs need to be done for the club to be able to function – coordinator, secretary, fish recorder, clerk of the scales and treasurer – but these posts will carry no special voting privileges, just the gratitude of other club members for the volunteers undertaking such duties.

In order to develop both the angling and social sides of the club, we will endeavour to purchase equipment that enables both individuals and families to participate in club events. This may include safety equipment, such as lifejackets etc., or more expensive items such as tents for club camping trips.

Where possible, we will also try to obtain angling equipment for newcomers to the sport to be able to use, thereby enabling them to have a taste of angling before they go to the expense of purchasing their own tackle.

Child Protection

In relation to child protection issues, all correspondence should be marked for the attention of the child protection officer, currently Mrs Rebecca Williams. (Telephone enquiries can be answered at 07704 602180.) Both the club secretary and coordinator will be CRB or DBS checked as a matter of course.

Members of Baywater Anglers are fully aware of the issues involved in Child Protection and understand that the abuse of young people and children can take the form of physical, sexual, emotional abuse or neglect. We therefore want to ensure that both ourselves and any children and young people attending Baywater Anglers events will be safe. All adults employed to work with the club, such as AAPGAI (Advanced Association of Professional Game Angling Instructors) coaches, will therefore be checked for their suitability through the Criminal Records Bureau, as will any volunteer working upon a project related specifically to younger people.

If any child or young person comes forward with a disclosure, they will be able to make it to either the child protection officer or coordinator, both of whom have received training in child protection issues. Similarly if any other adult members of Baywater Anglers receive a disclosure, they should inform, as soon as possible, either the child protection officer or coordinator, who will then inform the Social Services Team on 0845 6000388 immediately.

If a child tells an adult member that something has happened:-

Do	Don't
Allow the child to do the talking.	Postpone or delay the opportunity to listen.
Listen – take the child seriously.	Ask leading questions.
Tell the child that you believe them and that it is not their fault.	
Remain calm and caring.	Allow your own feelings (such as anger and pity) to surface.
Allow the child to finish.	Make false promises (that you will keep 'the secret', for example).
Record the conversation (disclosure) as soon as possible afterwards (it could be helpful to use the child's own words where possible).	Interpret what you have been told, just record it.
Tell the child that you are going to contact Social Services/Police Child Protection team.	
Keep the disclosure in a secure place.	

We understand that it is **not** the duty of anyone receiving a disclosure to make a decision on whether abuse has actually taken place; they just record the details of concern and pass them on to the Social Services team.

Recruitment

Baywater Anglers will seek to recruit new members from all branches of local communities, providing new members with training and safe opportunities to participate in sea fishing. It is our intention to promote angling as a whole family sport which engages parents and children in quality time and purposeful activity.

While we recognise that young people are the future of sea angling, we believe that very young children, i.e. those still at primary school, **must** be accompanied to **waterside** activities by a parent or responsible adult. This is for two reasons. The first, and primary consideration, is the safety of the children, avoiding any situation where numbers of adults are insufficient to maintain a safe charge over the numbers of young people present, while the second is because we feel that, without parental involvement, they are less likely to be offered further opportunities to practice the skills that they need to develop. For this reason Baywater Anglers will not accept membership applications from solitary children of primary age. Instead they must form part of a family application.

Training

At Baywater Anglers, we have introduced the CAST training scheme with starter, Level 1, Level 2 and Level 3 certificates to mark the competency of anglers as their skills develop. Some club events will focus on training aspects of the scheme, with volunteer helpers to administer training, but there will also be social and recreational events where members are free to enjoy the company of their friends and family.

Some training events may call upon the services of external trainers. Where this is the case, such instructors will hold either an Angling Trust, Level 2 Leading coach or AAPGAI (Association of Advanced Professional Game Angling Instructors) qualification, which carries first aid and DBS requirements, or similar award with these same requirements. We will not be employing instructors without proof that their qualification carries a requirement for regular DBS (Disclosure and Barring Service) checks to establish their suitability for working with young people.

In relation to the initial and continuing assessments of angling skills, these will rest with the Coordinator, who is also the principal trainer, as will the administration of the scheme. However resources to help develop angling skills will be made available, sometimes at a small charge, to all members of the club or placed upon the club website at www.seafishing4fun.org.

Health and Safety at Club Events

At club events, all volunteer helpers have a duty to ensure the safety of all young people present, ensuring that they are not, or do not put themselves, at risk. All volunteer helpers will therefore be vigilant to the safety of young people, helping them to develop safe angling practices and guarding against dangers such as their being accosted by unknown members of the public. It will also be the duty of the coordinator, or designated deputy, to carry out a risk assessment before each event and, in particular, to examine the weather and sea conditions prior to an event so that a decision can be made as to whether or not it is safe to proceed. His, or her, decision, will be final and can be accessed on 07704602180.

Where a club event involves the hire of a charter boat, Baywater Anglers will only use professional, Department of Trade recognised skippers with all necessary qualifications and safety checks carried out on their vessels. We will, in addition, maintain a stock of child sized lifejackets to ensure that all junior members have access to correctly fitted lifesaving equipment in case of problems developing once the trip is underway. These will also be available for club members to use if they are invited out on trips by other friends.

At open events, club volunteers will be able to keep in contact via walkie talkies or mobile phones while a first aid kit will be kept with a designated person. Any person having a complaint against another, or wishing help for any reason, should make contact with a steward, who will be recognisable in dayglo safety vest marked with Baywater Anglers. These will deal with all minor issues but the leader of the event should be applied to in relation to larger issues. These may include all decisions in regard to resolving complaints or rendering assistance to wheelchair users or others.

In the event of antisocial behaviour leading to complaints, the event leader will, in the first case, use his or her own judgement as to the severity of the response. This will take into account the fact that Baywater Anglers is a friendly club which wants its members to enjoy each other's company. If it is a minor disagreement which can be sorted out amicably then so much the better. However, if the incident is more severe, for example with behaviour of a bullying nature or indeed any behaviour likely to bring the club into disrepute, then the leader will take immediate action to curtail the behaviour and collect evidence as to what actually happened, making notes as to exactly what took place. He, or she, will then inform the coordinator and, if child protection issues are involved, the designated contact for such matters. These will then decide upon a course of action, storing any notes on the incident and discussing the matter with outside agencies if appropriate.

At the next open meeting the cause of the concern will be raised with the members present, who will be asked to decide upon the expulsion, suspension or other disciplinary action to be taken. Baywater Anglers does, however, take bullying so seriously that anyone guilty of this offence will be expelled from the club without return of their subscription.

Access

Baywater Anglers believes strongly that disabled people should have the opportunity to fish, deliberately selecting safe and accessible marks for the majority of its events. We will also dedicate web space to articles designed to help disabled people to succeed in their fishing and to explore alternative approaches that will make their pursuit of the sport somewhat more comfortable. In addition, we will make representations to local authorities on issues that could affect their access to the sport, e.g. our recent discussions with Torbay Harbour staff as to the difficulties faced by wheelchair users as they made their way around the harbour.

Procedural and Safety Reviews

In regard to the safety of all its members, though particularly that of young people, Baywater Anglers will consult not only with adult members but also with younger members as to the safety procedures that they would like to see in place at club events. These matters will then be raised at an open club meeting and steps taken to ensure that, where practical or desirable, such measures are implemented and any policy documents reviewed and amended accordingly.

Code of Conduct

While we believe that Baywater Anglers members are nice people who look after each other and the environment, we would suggest the following as an appropriate code of conduct for individuals engaged in the sport of sea angling:

1. Think very carefully about your own safety and the safety of others around you. Let people know where and with whom you are going to fish, giving an approximate time of return.
2. Keep your eye on the sea state and what the weather is doing. Your safety may depend on it since the state of the sea can change dramatically in a very short space of time. Be aware that every year anglers die through being swept off rocks in isolated locations and do not put yourself at risk in this manner.
3. Check your tackle thoroughly to make sure that is safe to use. Shock leaders must be in use for all bottom fishing.
4. Be considerate, for example be prepared to share your fishing spot with others, making sure that there is enough room between you for all to fish comfortably.
5. Try not to cast over the person next to you. While miscasts do happen, it can be very annoying if this happens again and again.
6. Look after the environment, leaving it as clean, or cleaner, than when you first arrived.
7. Look after the fish that you catch, returning alive any that are undersized or humanely killing, at once, any that you intend to keep for eating.
8. Dispose of any broken or unwanted tackle properly. Fishing line, in particular, can represent a serious danger to wildlife and should be cut into very short lengths before being placed in a bin.
9. Enjoy the peace and quiet of your own fishing and respect the fact that others like peace and quiet too.
10. Make sure that you bring along enough bait for your whole fishing session. Approaching strangers for more if you run out is neither safe nor desirable.
11. Make sure that any knives, hooks or sharp objects are properly stored in your bag after use, well away from the curious hands of small children that may be nearby.
12. If fishing from a boat, make sure that you are properly equipped with a lifejacket and suitable clothing. Check that the boat owner has suitable safety equipment on board, including the correct pack of flares for the intended passage, backup form of propulsion, VHF radio etc.

Emergency Procedures

The nature of the activities involved in angling mean the range of potential issues that may arise in an emergency could vary greatly. An emergency may only directly involve one participant, but remember that all coaches and volunteers have an equal responsibility in ensuring the safety of the rest of the group.

Medical Emergency

The event should have a designated first aid officer which, for all Baywater events, is Martyn. It is his responsibility to determine the severity of any incident and the most appropriate course of action. The priorities for deciding this are to:-

- Prevent further injury or deterioration.
- Secure the safety of the rest of the group.
- Seek qualified medical assistance as soon as possible.
- Contact the parent, guardian or supplied emergency contact.

Where it is not possible or it is considered inappropriate to move the injured person, the emergency services should be contacted directly. Be sure to provide clear information. Where access may be difficult this must be made clear. Always ensure that you are aware of the location of the nearest landline telephone as a mobile service may not be available. An accident report form (the book will be in Martyn's vehicle) should be completed as soon as possible after the event.

Other Emergencies

Other incidents that could arise during an angling event are:-

Drowning or immersion in water

Lightning storms and unexpected weather

Absconding or missing participants

Drowning or Immersion

Do NOT jump in after the victim. Your safety is paramount. Observe the following guidelines:-

Call for the emergency services.

Use a landing net handle or long branch to try to reach the victim.

For greater distances, use a throwing line or buoyancy aid.

If you must enter the water, hold on to someone on the bank.

In deeper water, take one end of the throwing line with you.

If the victim is panicking approach from behind; do not let them grab you or they will climb up you to get themselves out of the water.

If necessary, wait for the victim to start to lose consciousness before approaching.

Transfer the victim to the bank as quickly as possible and begin CPR if necessary.

Treat for hypothermia. Even in the summer this can be a real danger.

Lightning Storm and Unexpected Weather

Sudden, violent storms do occur. Lightning is a particular danger to anglers, although the warning signs are usually received well in advance.

Play it safe - evacuate the event until the danger has passed.

If you are caught out, immediately put down fishing rods and evacuate to a safe area.

Vehicles in car parks are as good as anywhere and also provide welcome shelter from any accompanying rain.

Do not waste time packing up equipment - it will still be there when the danger is over.

Missing Participants

Even where every precaution has been taken and where experienced and competent assistants are involved, this can still occasionally happen. This may be as a result of an accident, a dispute, distraction or boredom. Whatever the cause, where children are concerned, it is distressing to both coaches and participants until the missing person is found.

If a person is found to be missing:

- Stay calm but act promptly. Once you realise a participant is missing conduct a rapid search of the water perimeter.
- If the missing person is not found, one volunteer should gather the rest of the group while all other volunteers conduct a thorough search of the water perimeter.
- If still missing, extend this to the whole site, paying particular attention to any buildings or other structures.
- Now contact a parent or guardian. They may be able to give clues.
- Have one coach/volunteer drive around perimeter roads for a reasonable distance.
- If not found, inform the police and continue to search whilst you await their arrival.

Privacy & Data Protection Statement

Website

The Baywater Anglers website – www.seafishing4fun.org - does not store or capture personal information, but merely logs the user's IP address that is automatically recognised by the web server. We do not use cookies for collecting user information and we will not collect any information about you except that required for system administration of our web server.

Data Protection

Baywater Anglers is a privacy conscious organisation and is strongly committed to your right to privacy. That is why we have drafted a Privacy and Data Protection Statement, which follows guidelines set out in the General Data Protection Regulation 2018.

The General Data Protection Regulation 2018

The General Data Protection Regulation 2018 set rules for processing personal information and applies to structured paper records as well as data held on computers. The provisions of the General Data Protection Regulation 2018 will apply to all records, including those structured other than by reference to the data subject, and completely unstructured files.

Baywater Anglers' Use and Storage of Data

The Data Protection Act states that those who record and process personal information must be open about how the information is used and must follow the eight principles of 'good information handling'.

These principles state that data must be:

- Fairly and lawfully processed
- Processed for limited purposes
- Adequate, relevant and not excessive
- Accurate
- Not kept for longer than is necessary
- Processed in line with your rights
- Secure

Personal data will not be transferred outside the European Economic Area unless that country provides a adequate level of protection

By law, data controllers, including Baywater Anglers, have to keep to these principles. How does Baywater Anglers collect data?

There are several means by which Baywater Anglers collects personally identifiable data, for example:

- Through a recruitment application form
- For the purposes of making an application for grant funding
- Acceptance for inclusion on a mailing list or membership database
- For research, surveys, votes on club issues, for monitoring purposes or for events where personal data is a necessary condition of booking, e.g. a camping rally
- By entering into email or telephone correspondence with a member of Baywater Anglers

All personally identifiable information provided to Baywater Anglers is processed in accordance with the principles of the General Data Protection Regulation 2018.

Is information passed to third parties?

Under normal circumstances, Baywater Anglers does not pass any personal information onto third parties. There are two exceptions:

1. When, after discussion with the person concerned and **only** with that person's agreement, he or she has agreed to undertake a role in a community project or other activity where personal details may be necessary to secure funding or access to resources. This may, for example, require personal data for the purposes of completing an application for grant funding or other necessary forms such as a booking form for a camping rally.
2. It is Baywater Anglers' policy to disclose information to third parties only if explicitly required to do so by United Kingdom Law or in circumstances where your consent has been obtained.

Baywater Anglers **does not** collect or compile personally identifying information for dissemination or sale to external parties for marketing purposes or host mailings on behalf of third parties. However, Baywater Anglers **will** occasionally use your personal information to let you know about future events.

Your rights

Under the GDPR, you have various rights with respect to our use of your personal data:

Right to Access

You have the right to request a copy of the personal data that we hold about you by contacting Baywater Anglers' Information Requests and Complaints Manager at Martyn.green1@tiscali.co.uk. Please include with your request information that will enable us to verify your identity. We will respond within 1 month of request. Please note that there are exceptions to this right. We may be unable to make all information available to you if, for example, making the information available to you would reveal personal data about another person, if we are legally prevented from disclosing such information, or if there is no basis for your request, or if it is excessive.

Right to rectification

We aim to keep your personal data accurate and complete. We encourage you to contact us using the club contact details provided on our website – www.seafishing4fun.org - to let us know if any of your personal data is not accurate so that we can keep your personal data up-to-date.

Right to erasure

You have the right to request the deletion of your personal data where, for example:

- the personal data is no longer necessary for the purposes for which they were collected
- you wish to withdraw your consent to processing
- there is no overriding legitimate interest for us to continue to process your personal data
- your personal data has been unlawfully processed.

Right to object

In certain circumstances, you have the right to object to the processing of your personal data where, for example, your personal data is being processed on the basis of legitimate interests and there is no overriding legitimate interest for us to continue to process your personal data. Right to restrict processing

In certain circumstances, you have the right to request that we restrict the further processing of your personal data. This right arises where, for example:

- you have queried the accuracy of the personal data we hold about you and we are verifying the information
- you have objected to processing based on legitimate interests and we are considering whether there are any overriding legitimate interests
- or the processing is unlawful and you elect that processing is restricted rather than deleted.

Right to data portability

In certain circumstances, you have the right to request that some of your personal data is provided to you, or to another data controller, in a commonly used, machine-readable format. This right arises where you have provided your personal data to us, the processing is based on consent or the performance of a contract, and processing is carried out by automated means.
